OBJECTIVE

Govt. T. Romana College, Aizawl, Mizoram and Janata College, Kabuganj, Assam have come to a mutual agreement to co-operate in educational and co-curricular activities in areas of mutual interest, for period of 3yrs (2023-2026).

TERMS

Non-Discrimination.

3. This Agreement may not be assigned or changed by either party without the advance written consent of the other. This Agreement shall be binding upon the heirs, personal representatives, successors, and permitted assigns of both parties.
4. Administration of this Agreement shall be the responsibility of the office of the Principal Janata College Kabuganj, represented by its Principal and office of the Principal, Govt. T. Romana College, Aizawl ; Mizoram, represented by its Principal. Any additions, changes or deletions must be approved by the legal representatives at both colleges. All notices shall be in writing and shall be directed to these individuals as follows.
5. Both parties shall be released from their respective obligations in the event of national emergency, war, prohibitive governmental regulation or if any other cause beyond the reasonable control of the parties or either of them renders the performance of this contract impossible.

Warranty: Each of the parties warrants it has the legal power to enter into this Agreement.
